A Motion to approve order of bond application to TCEQ, payment of bond application review fee to the Texas Commission on Environmental Quality, and adopt the Order Authorizing Application to the Texas Commission on Environmental Quality for approval of projects and bonds, and authorize all other action necessary related to the Bond Application Report was made by Director Small and seconded by Director Stuksa. The motion passed unanimously.

A motion to adopt resolution relating to wage rate scales, (federal rate) was made by Director Stuksa and seconded by Director Granquist. The motion passed unanimously.

6. FINANCIAL ADVISOR

Mr. Blitch presented a report on what would occur if the bonds were sold under current market conditions to give the Board of idea of what that would look like.

He then presented info on the tax rate and options for 2025.

7. ATTORNEY

A motion was made to authorize attorneys to file special purpose district financials and tax report, by Director Small and seconded by Director Stuksa. The motion passed unanimously.
